- Excellent elastic wear as prescribed




Congratulations to Esther Moore, who is our Patient of the Month for December! Esther received 50 extra rewards hub points as well as a certificate. Congrats, Esther!

MONTHLY TOPIC: WHAT TO EXPECT IN A CONSULTATION

The initial consultation for braces is an hour long complimentary, appointment for both adults and children. You will meet with our treatment coordinator. Jean, and she will start off by giving you a tour of our office. After the tour, Jean will review the health history form with you and discuss any concerns that you or the dentist may have. She will then proceed with taking records, including x-rays and close- up photographs of the face and teeth. Once the records have been obtained, Dr. Spoonhower will review them and do a thorough exam of the mouth. He will discuss any recommended orthodontic treatment with you and Jean will also show you the braces, any appliances that may be recommended, explain in detail the process, and what to expect from start to finish. Jean will also present all of the financial information and office protocols. You will leave with a folder containing a copy of all of the records that were taken, the treatment plan and financial information so that you have all of the information you need to make an informed decision about starting orthodontic treatment with our office. Once you start treatment with us, you become family and we do everything we can to make you feel comfortable, welcome and have fun along the way!

Each month we feature a different color combination you can get on your braces with the elastic ties! We even give the color combination a fun, cool name and have it on display so you can see what it will look like!

Many insurance policies have a lifetime orthodontic benefit that is distinct from regular dental insurance. Insurance policies vary, so we will review your insurance to determine the appropriate course of action. (Once treatment has started, we will file your claims).

Our office is committed to helping you maximize your insurance benefits. Due to the fact that insurance policies vary, we can only estimate your coverage in good faith, but cannot guarantee coverage due to the complexities of insurance contracts. Please inform us, too, of any changes to your insurance coverage.
