Retainers play a crucial part in your orthodontic treatment. When the braces come off, your teeth will naturally want to return to their original positions. Our goal is to keep your teeth in the positions we all worked so hard to achieve. By consistently wearing your retainers,

teeth will "remember" where they're supposed to be. So what happens if it's lost or broken?

Storing Your Retainer

The best way to keep your retainer from getting lost or broken when not in your mouth is to keep it in the case we provide you. All too often, retainers get thrown away by accident! They can also be stepped on or chewed up by pets. So, take care of your retainers and keep them in their case if you're not wearing them!

**Getting Replacements** 

If you do lose or break your retainers at any point, it's important to contact our office right away to discuss the proper procedure to obtain a replacement. Depending on when you completed treatment, you may have been given a model of your teeth that we can potentially remake a new retainer off of. Otherwise, we may need a scheduled appointment to scan your teeth. A broken or lost retainer can mean re-treatment and additional costs if you wait too long to get a new one, so please contact us right away if this happens to discuss options.

Fixing a Bonded Retainer

If you've broken a bonded retainer, you will need to contact our office to have it re-bonded in the correct position at no charge to you. Please do not attempt to remove a bonded retainer by yourself. These are set onto your teeth with dental bonding and can damage your teeth if removed incorrectly.

Regardless of the kind of retainer issue you have, the important thing is to <u>PLEASE contact us right away</u> so we can assist with you with fixing/replacing the retainer before your teeth shift!

Due to the fact that insurance policies vary, we can only estimate your coverage in good faith, but cannot guarantee coverage due to the complexities of insurance contracts. Please inform us, too, of any changes to your insurance coverage.
